  - a. The information has been categorized as best as possible under various salary heads according to IPRS Version 2.2; where a break-up was not available, the salary has been considered only as 'Maximum earning potential'.
  - b. Proof of acceptance of the offers is indicated by student signing the offer letter. The acceptance of offer for 152 students out of 237 could not be verified.
4. The number of students opting out of the placement process and students on sabbatical has been established through written communication from the students/recruiting companies.
