CRISIL has audited the placement report prepared by the Symbiosis Centre for Management and Human Resource Development, Pune (SCMHRD) for the summer internship placements of the 2013-15 batch of the MBA programme. The placement report is the responsibility of SCMHRD. Our responsibility is to validate the information provided in the report with the relevant documentation, and comment on the placement report's conformance with the Indian Placement Reporting Standards (IPRS), version 2.1.

In this context, CRISIL confirms the following:

- 1. For the purpose of the audit, we have obtained all the information and explanations which, to the best of our knowledge and belief, were necessary. In our opinion, the placement report does comply with IPRS, version 2.1.
- The validation of information presented in the report is based on communication received by SCMHRD from recruiting companies. CRISIL has not independently sourced any information or documentation.
- 3. CRISIL has not been able to verify the offer for 18 students and this has not been used as calculations in the report.
- 4. CRISIL has verified the information with respect to job function, location, and stipends presented in the report based on communication received from recruiters. Data regarding function for 69 students and location for 52 students (including one international placement) has been verified from records maintained by the institute.
- 5. Proof of acceptance of the offers was not available for 98 out of 145 students.
- 6. The number of students opting out of the summer internship placement process has been established through written communication from those students.
